Instructions for the Teacher:

This quiz can be executed in a learning management system (LMS) or another online format that allows students to take a quiz (e.g. Google Forms, Microsoft forms, etc.). The quiz is organized into multiple banks/pools of questions, each of which focuses on a different aspect of academic integrity. Within an LMS, each banks/pools can be added individually to build the quiz. The instructor can adjust quiz settings to pull the desired number of questions from each bank/pool, which ensures each student receives questions on each topic. My approach is to allow unlimited attempts at the quiz, which includes all the questions. I require 100% mastery of the quiz before students can access other assignments in the LMS. I provide feedback for all questions except the questions in the sanctions bank/pool. I use quiz settings that allow students to see the questions they answered incorrectly, along with all the answer options, after each attempt. I never reveal the correct answers. I require students to take the quiz one question at a time, which is an easier setting to accomplish in an LMS compared to other quiz formats. In my classes, any points associated with this quiz are arbitrary and are only intended to track mastery of the quiz. This quiz is tailored to the Texas A&M Aggie Code of Honor, Aggie Core Values, and Sanctions for violations of the Aggie Code of Honor.

*Please note, that to ensure academic honesty, this version of the Academic Honesty Quiz does not include banks/pools of questions and all questions are randomized. Follow the instructions on page 1 to gain access to the Instructor's version of the quiz, which includes banks/pools of questions, question answers, and feedback for answers.

Instructions for students:

"An Aggie does not lie, cheat, or steal, or tolerate those who do". As an Aggie you are expected to conduct yourself in accordance with the Aggie Code of Honor, which includes not engaging, participating, or allowing any form of academic dishonesty. Ignorance of the rules is not an excuse for noncompliance. As such, you should be aware of the different types of academic dishonesty and what types of actions would be considered academic dishonesty.

 necessary to score 100%. You have 1 hour for each attempt. Points on this quiz are arbitrary and are only
 meant to show your progress toward mastering the quiz. The points of this quiz will NOT be considered
 for your grade in the course.
- Email me with <u>your specific questions</u> if you are still are struggling to master the quiz after 7 attempts. I will help clear up any confusion or misunderstandings you have, but I will NOT give you the answers.
- After studying the Code of Honor and mastering this quiz students will be able to:
 - O Distinguishing between cheating, fabrication, falsification, multiple submissions, plagiarism, and complicity.
 - Recognize examples of cheating, fabrication, falsification, multiple submissions, plagiarism, and complicity.
 - Recognize the shades of academic dishonesty and how multiple types of academic dishonesty can be committed simultaneously.
 - Recognize the consequences for violations of the Aggie Code of Honor

Shelby is writing a research paper on Potato Blight. Below are two web sources she found online and then an excerpt from her report. Both sources qualify as approved resources by her instructor. Shelby only cited Website #2 for her paper.

From website #1

Late blight of potatoes and tomatoes, the disease that was responsible for the Irish potato famine in the mid-nineteenth century, is caused by the fungus-like oomycete pathogen <u>Phytophthora infestans</u>. It can infect and destroy the leaves, stems, fruits, and tubers of potato and tomato plants. Before the disease appeared in Ireland, it caused a devastating epidemic in the early 1840s in the northeastern United States.

From website #2:

Potato and tomato blight is a disease caused by a fungus-like organism that spreads rapidly in the foliage and tubers or fruit of potatoes and tomatoes in wet weather, causing collapse and decay.

It is a serious disease for potatoes and outdoor tomatoes, but not as common on tomatoes grown in greenhouses.

Blight is specific to tomatoes, potatoes, and some ornamental relatives of these two crops. Cases have been recorded on ornamental Solanum species (e.g. <u>S. laciniatum</u>), and <u>Petunia</u>.

Excerpt from student's report:

Late blight of potatoes and tomatoes, which was responsible for the Irish potato famine in the mid-1800s, is caused by the fungus-like oomycete <u>Phytophthora infestans</u>. It can infect and destroy the leaves, stems, fruits, and tubers of the potato and tomato plants.

In the rest of this paper, I will aim to explain the life history, characteristics, and economic impacts of this plant pathogen. These traits have influenced both Irish and American history, and.......
